Minimum bid specifications for a new 2025-2026 Semi Truck Tractor. Truck shall be class 8 rated at minimum 66,000 lb GVWR and 95,000 GCWR. Truck and all components shall meet requirements below and all components shall be rated for the use listed within specifications. All listed components shall be installed and in working order. Truck shall meet all current DOT regulations and shall be DOT inspected prior to delivery.

Use

• Truck will be used to pull belly dump trailer. Truck will be used for gravel and rock hauling and will be operated off highway with occasional rough off-road use.

Engine

- Displacement 15 liter
- Minimum 500 HP or above diesel engine.
- Minimum 160-amp alternator
- Bug screen
- 120 V 1500-watt block heater
- All silicone coolant hoses
- Shall have upright exhaust
- Shall have spin on fuel and oil filters full flow
